This has reference to your proposal submitted to AICTE for considering grant of approval for increase in intake/ additional courses/ variation in intake for the academic session 2008-09.

The proposal was examined by duly constituted Hearing Committee, and the following deficiencies were observed:

1. Present Director is overaged and hence not eligible as per AICTE norms.
2. Sr. level faculty in cadre ratio as per AICTE norms not available in the course in which increase in intake is proposed.
3. Ph. D. qualified faculty not available for the existing course in which increase in intake is proposed
4. The Institute not-eligible for Bio-Tech course as one batch of Chemical Engineering is not yet passed out.
5. Ph. D. qualified faculty not available for the proposed M.Tech course.

In view of the above deficiencies, your request for increase in intake/ additional courses/ variation in intake was not granted. You are hereby required to rectify the above-mentioned deficiencies and submit fresh proposal with all the relevant documents in support of the compliance of the deficiencies and requisite fee to the Concerned Regional Office of AICTE for further necessary action.

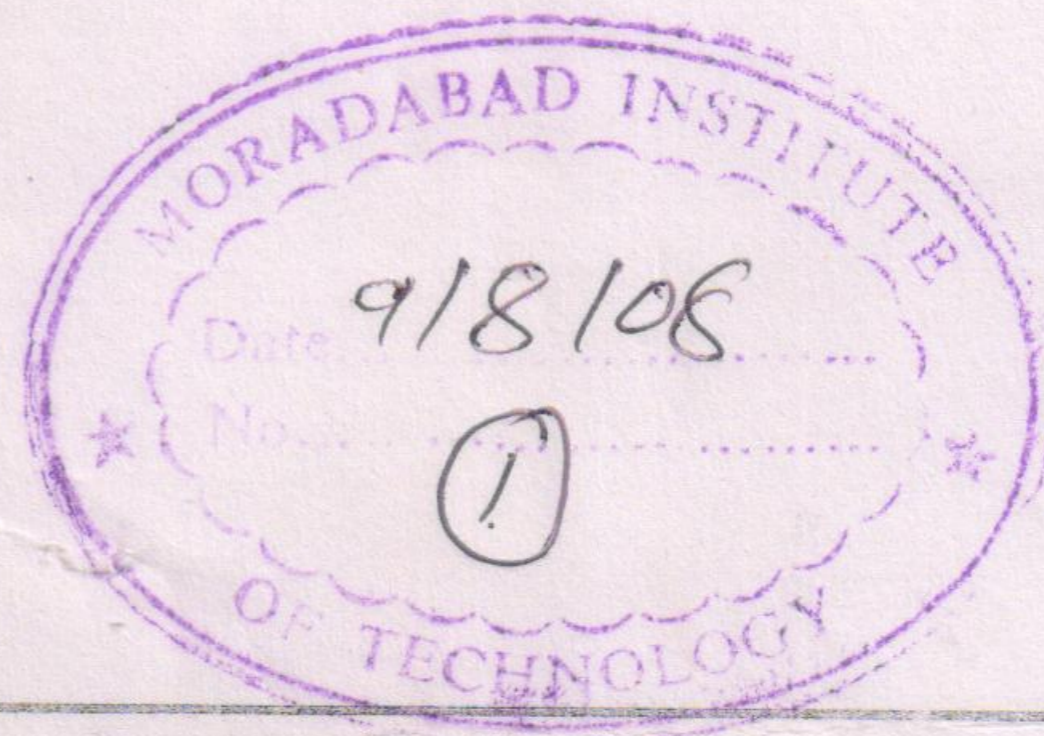


