- 2. Remaining duties should be assigned after 5 pm in the hostels, and nearby colonies.
- 3. A meeting of the some important persons from the nearby colony and hotel, dhaba owners to request them, if there is any incidence in their knowledge, then should inform to the college administration immediately, so that timely action may be taken.
