Sir,

As per feedback received from the students on syllabus of Mechanical Engineering Branch, the Following modifications may be incorporated in the syllabus.

- (1) A few practical labs can be added to enhance the actual learning among students and make them industry-ready, like the Non-destructive lab. Engineering mechanics lab, etc.
- (2) The syllabus of some subjects is very lengthy, so it is impossible to complete it in an effective manner. It must be split into two parts, like applied thermodynamics, kinematics of machine, Manufacturing processes, fluid mechanics and machinery, etc.
- (3) More number of lectures should be added to complete the subjects, especially in numerical subjects.

 - ➤ In Paper code KMBN HR04, Syllabus of some units are quite lengthy, there must be a balance between the need and availability of the content.
